Dear Ms. Ferman:

We are in receipt of your letter, dated March 4, 2008, responding to our inquiry concerning the status of investigation on the above referenced matter. This is to follow up on your letter.

In your letter, you stated that your predecessor and the former District Attorney Bruce Castor "terminated" the investigation and "closed" the above referenced matter based on the advice the DA's Office received "in July 2006" from "counsel" representing Philadelphia Mil Al Church (the "alleged victim" and complainant) that "the Church did not want us [the DA's Office] to continue with the investigation."

We, therefore, respectfully ask you to identify his or her ["Counsel for the alleged victim"] name who you stated "was regularly in contact with this [DA's] office" in the capacity of a "legal counsel to represent the institution [Philadelphia Mil Al Church]" and who you stated "advised the DA's Office that the Church did not want us to continue with the investigation because they preferred to handle the alleged theft as an internal matter."

In addition, we respectfully ask you to provide us with copy of Counsel's letter to the DA's Office advising the DA's Office.

Of note is "Reverend Kyung Kyo Han" in your letter. To our best knowledge and information, he is not a pastor.

While awaiting your response, we declare in no uncertain terms that we neither authorized anyone to advise the DA's Office to stay "regularly in contact with this office [the DA's Office]" nor instructed anyone to advise the DA's Office that "the [Philadelphia Mil Al] Church did not want us [the DA's Office] to continue with the investigation".

In fact, we - the victim *and* the complainant in the captioned case - did not retain "legal counsel to represent the institution during the investigation," contrary to your statement.


We did not and do not have legal counsel representing us. May we respectfully ask you whose advice the DA's Office took and "closed" the case?

As we wrote to you in our recent letter of February 14, 2008, we received no communication from the DA's Office whatsoever since we filed the criminal complaint.

We respectfully ask you to reopen the case without further delay.

Dear Reverend Yi:

I have received your correspondence dated February 14, 2008 regarding the above-referenced matter and write in response thereto. In May 2006, this office investigated an alleged theft of approximately \$57,000 by Reverend Kyung Kyo Han from the Philadelphia Mil Al Church. It was alleged this theft occurred in February 2006. The investigation was completed in August 2006.

During the course of the investigation, Philadelphia Mil Al Church (the alleged victim) retained legal counsel to represent the institution during the investigation. Counsel for the alleged victim was regularly in contact with this office. In July 2006, counsel for the alleged victim advised the District Attorney's Office that the Church did not want us to continue with the investigation because they preferred to handle the alleged theft as an internal matter. Former District Attorney Castor decided to terminate the investigation at the victim's request. This decision was immediately shared with the victim's counsel and the matter was closed.
